

34th Annual Wisconsin Valley Art Association Memorial Art Exhibit



Location: The Loft at the Center for Visual Arts Center (CVA), 427 4th Street, Wausau, WI

Dates: **Registration deadline: Monday, April 25, 2011**

Artwork delivery to CVA: Deadline: Tuesday, May 3 at NOON (*see below for drop-off times*)

Exhibit: Friday, May 6 to Sunday, June 12 .

Reception and awards presentation: Friday, May 13, 2011 from 5-7 pm.

Eligibility and Fees:

Open to all current Wisconsin Valley Art Association (WVAA) members.

Membership dues must be paid by March 17, 2011, to be eligible.

Past members renewing their membership **after the March meeting**, will be charged an **additional \$10.00 late fee** to participate in the WVAA Memorial Art Exhibit.

New members may pay membership dues along with registration fee until the

Exhibit Registration Deadline of Monday, April 25, 2011.

There is a non-refundable registration fee of \$20.00 for up to 2 pieces of original artwork.

Artwork may not have been previously exhibited, either at a past WVAA Memorial Art Exhibit, or at the CVA. Artwork must be original, and created within the past two years.

A third piece may be submitted for the exhibition for an additional \$10. Clearly indicate which piece is to be your third piece. If gallery space does not allow for that piece, the \$10 will be refunded and you will be notified to pick up the piece by Friday, May 6.

Eligible Media include: oil, acrylic, watercolor, sculpture (wire, glass, metal, wood), pencil/pastel drawings, photography, mixed media, carving, hand thrown pottery and ceramics.

Prohibited: any work from commercially available kits, molds, castings, pre-cut parts, patterns, plans or copies of other artists work. Pieces deemed not fitting the above criteria will not be included in the show, and the artist will be notified to pick up the work.

Display Requirements

Maximum size for two-dimensional pieces is 48" x 48" framed with a 50 lb. maximum weight.

Three-dimensional pieces cannot exceed 50 lbs. Stands will be provided or may be part of the sculpture.

If applicable, two-dimensional work must be protected by Plexiglas, not glass.

In the occurrence of glass breakage on pieces framed with glass, the piece will not be exhibited.

Hanging pieces may be framed or unframed, but must include **wire** across the back for hanging. **No saw tooth hangers** will be allowed. Unframed pieces must have edges properly finished. The gallery suggests that fine artwork have simple frames with white or off-white mattes. Other hanging art should be on a rod or brackets ready for hanging.

All pieces must be completed and delivered to CVA by NOON on Tuesday, May 3 2011.

No wet paint, glue, etc. on pieces will be accepted by the CVA or the hanging committee.

If your work does not meet the above criteria, it will NOT be included in the show and you will be notified on Tuesday, May 3, to pick up your artwork from the CVA by Friday, May 6.

Liability:

All artwork will be insured by the CVA against damage and theft while in the care of the gallery. Entrants are responsible for insuring work while in transit to and from the exhibit. Submission of the applicant form constitutes agreement to all conditions listed in this prospectus.

Sales:

Artists are encouraged to place their work for sale. If artwork is sold, the CVA will retain a tax-deductible donation of 33% of the listed price. If you need assistance on pricing your artwork for sale with consideration of the CVA commission, please contact the CVA at (842-4545) or Bobby Walker (693-1041).

All sold works must remain in the gallery the entire length of the exhibition. Payment will be made to the artist at the end of the exhibit. All sales will be handled through the CVA and the CVA will make payment.

Entry Process:

A check for the registration fee should be made payable to the Wisconsin Valley Art Association, and accompanied by the art registration form, due to Bobby Walker **Monday, April 25 2011.**

Absolutely NO registrations will be accepted after this date.

Artwork may be delivered to the CVA Gallery on Sunday, May 1 from 12:00 to 4:00; Monday, May 2 from 1:00 to 5:00.

If you cannot bring your artwork during these times, you may bring it up to The Loft Gallery at the CVA on Tuesday, **May 3, from 10:00 to 12:00.**

No artwork will be accepted after 12:00 NOON on Tuesday, May 3 2011.. You may call Bobby Walker (693-1041) to arrange a special appointment delivery. Times will be limited.

Starting at noon, the gallery will be closed, except for the WVAA hanging committee members, who are responsible for the placing & hanging of the exhibit.
